By signing below, I understand the following:

- All activities observed, undertaken, or performed as a volunteer shall be performed without promise, expectation, or receipt of compensation for services rendered and without expectation, promise, implied employment or continued efforts with the Town of Payson;
- Risk of injury or death may occur while performing duties for and on behalf of the Town, and I or my estate shall have no claim against the Town, and waive all claims or causes of action for physical injury or illness that may accrue by virtue of my services to the Town of Payson;
- I, indemnify and hold harmless the Town of Payson against any and all claims, demands, and/or liability of any kind or nature that may be brought against the Town by any part stemming from alleged wrongful acts or failures to act in my provision of volunteer service;
- Privileged and confidential information shall not be repeated, disseminated or disclosed in any manner, and if confidentiality of the Town is breached, I may be subject to civil and/or criminal sanctions;
- One shall not represent themselves as an employee of the Town of Payson, or act on behalf of the Town of Payson while serving in a volunteer capacity;
- Items obtained through volunteer services may not be circulated, reproduced, used without permission, or edited, without written permission from the Town of Payson;
- Promotion of or for personal gain while acting in a volunteer capacity for the Town of Payson will not be permitted;
- All activities must be coordinated, scheduled, supervised, and approved by Town of Payson staff, unless otherwise permitted in writing;
- The Town of Payson is not liable for uses of personal items/vehicles used while performing volunteer services;
- All information furnished here may be verified. I authorize all individuals and organizations named in the contract to release supporting information relative to such verification, and release such sources and the Town of Payson from liability for any claim that may result;
- The Town of Payson does not discriminate based on race, color, religion, national origin, sex, age, or disability. It is our intention that all qualified applications be given equal opportunity;
- This agreement serves as an acknowledgment of the working relationship between the volunteer and the Town of Payson, and clarifies expectations of both parties in relation to the volunteer commitment, maintenance of department operational standards, work to be performed, expectations risk, and adherence to the Town of Payson's policies and procedures. If at any time the volunteer violates any portion of this agreement or the Town of Payson does not see the benefit or need of volunteer assistance in a particular area, the volunteer may be dismissed from responsibilities outlined;
- Volunteer services may be discontinued for any reason, at any time.
